FROM THE BOARD

We trust that wherever you are and whoever you are with that you are all healthy and staying well in these uncertain times. We look forward to the time when we can all be safely together again.

The last Newsletter was published in March, 2020. Since then the Board met on May 2, 2020. All five of the Board members were present, three of them via phone. (Quorum met.) There were eight homeowners present, all via phone. Ramona Widick, treasurer, reported that as of May 2^{nd,} the balance in the US Bank Checking Account was \$67,550.27, and the balance in the US Reserve Account was \$125,800.90. At that time all of the Homeowners had paid their monthly fees on time, and all submitted bills through April 30th had been paid.

Neal Kania, president, reported that we made it through the winter without any interior water damage. Neal said that the heat tapes on Buildings F and G worked well. However, our electrical expenses were very high. They kept the ice from the roof, but caused a problem with the ice at the base. Next winter, Neal proposes putting the heat tapes in the rain gutters and in the downspouts, so we can eliminate all of the icicles and minimize the ice at the bottom. We may have to have these on a separate circuit. We need to test them on a specific building before we consider putting them on every building. Neal gave thanks to Frank Comber for proposing at the last Annual Meeting in July that the heat tapes be tried before re-building the roofs of F and G.

Neal also thanked Jim Coursolle for continuing the investigation for the water issues on the driveways. The water turns to ice and folks have a hard time getting to their mailboxes in the winter. Neal said that we still have to address this issue. Perhaps in the future, heat tapes on all the buildings would help this situation.

New Business: The Board approved our insurance contract with Auto Owners for \$29,994.57.

The Board discussed future projects:

- Putting a roof over each of the garbage corrals
- Removal of dead or dying birch trees
- Caulking stonework on the buildings at the point where it meets the asphalt or concrete

PROPERTY MANAGER'S REPORT, Lee Schultz

Lee Schultz, property manager, reported at the May 2nd meeting that Spring projects were underway.

• There was no interior water damage from the winter.

- However, In Bldg D the water line in the vestibule closet sprung a leak. Repairs are being made. And, a drainage pipe in the ceiling between the Hanford and Zingale units leaked. The entry way ceiling in D31 is being repaired.
- The painters were here to wash and paint Garage H and the Rec Center. Buildings F and G are the only buildings left to paint, one in July and one in August. The siding will be repaired, if needed, before the painting is done. All of the other buildings have been painted within the past two years. That will complete the painting of the entire complex.
- The piers were put in by the start of the fishing season, May 2nd.
- Custom Caretaking did not increase their cost for mowing for this year; it is the same as last year. The only new item in the contract is that the property manager will be notified BEFORE providing services such as pressure washing of patios, trimming of ornamental trees, etc.

*As of the printing of this newsletter, Lee gives us an update on things that have been done since the last Board meeting:

- All the roofs were blown free of pine needles and all front and back gutters were cleaned.
- The Brandy Board will be considering bids for tree and limb removal this year. Note the red ribbons tied on the trees to be removed. If you have any additional ideas, be sure to let Lee know.
- NOTICE TO ALL OWNERS OF AN EXTERIOR GARAGE: If the power is out, you cannot open the garage door. Solution: Install the 1702LM key Quick Disconnect. I have negotiated a group price with Lakeland Overhead Door. Parts and labor is \$50. This is an owner expense. Let me know if you want the installation.

BRANDY BOARD ELECTION

The small envelope is not identified by name or unit number, so when the votes are tallied, privacy is assured. Votes will be tallied in plain view during the Annual Meeting. If you mail the ballot, please be sure to post it in time for it to arrive before the Annual Meeting which is being held on Saturday, July 18th. If you choose not to mail the ballot, you may bring your envelope to the Annual Meeting to be counted.
