### FROM THE BOARD

Wishes for a happy fall to everyone! Hopefully you have had a chance to enjoy the beautiful colors, sights and smells of the season. May winter treat us kindly, especially this year!

The BLPOA Board has had two meetings since the last newsletter was published: the Annual Homeowners' meeting on July 18, 2020, and another meeting on October 3, 2020.

#### JULY 18th, 2020 MEETING:

- Four Board members were present, which constitutes a quorum; and there were twenty-four homeowners present—fifteen in person and nine via phone. Ramona Widick, treasurer, reported that as of July 18, 2020, we had \$41,799.42 in our checking account and \$125,821.87 in the reserve account. All homeowners' dues were paid through June 30, 2020 and all submitted bills had been paid to date.
- Neal Kania, president, reviewed that there were two vacancies on the Board, one because Laura Van Horne resigned, and another because Ginny Comber's term has ended. There were three candidates running for these two positions. Forty-eight votes were cast and counted. Sandy Hanford and Gene Cole were elected.
- Neal also reported that the heat tapes worked well on Buildings F and G last winter; however the electricity bills were high. Next winter the tapes will be turned on as needed. Neal also said that additional heat tapes will

be installed in the gutters and downspouts of Building F and G, and to the vestibule areas of Building B because of the ice on the asphalt last winter.\*

#### Old Business:

- The Board plans to add a roof to the garbage corral at Building G this fall; and sealing stones at the base of the buildings will also be done this fall.
- Neal reported on our Capital Improvement schedule for the foreseeable future.\*

#### New Business:

- The following items were discussed: the possible relocation of the mailboxes to the vestibules, the heat tapes on Building C to alleviate ice buildup, the poor condition of the roof on H garage, and that owners are not to dispose of big items in the garbage corrals.
- Laura Van Horne offered a formal proposal indicating that she would provide all services — the web page, directory, handbook, newsletter, calendar of events, and bookmarks for about \$600. Approval to be determined by the new Board. (Laura's proposal was later approved by the new Board. Debbie Harvey volunteered to administer the website.)
- Rich Clancy, homeowner, expressed his concerns with various topics around the complex tree removal, benches in the vestibules, repainting of picnic tables, walking path, exterior garage locks, boat docks, H garage, cleaning of dryer vents, and power washing in vestibules.\*

### OCTOBER 3RD MEETING:


- All five Board members were present, with George Oberlander present via phone. Seven homeowners were present and seven via phone. Ramona reported that we had \$53,168.75 in checking and \$116,004.32 in our reserve account.
- Neal, Board president, reported that heat tapes will be added to Building B and to the down spouts in Buildings F & G. Efforts will be made to reduce electrical costs. The roofs over the two garbage corrals will be constructed soon. He also said that the Board will continue to research and discuss the possible relocation of the mailboxes.\*

#### New Business

Eurasian Watermilfoil Issue: Cheri Hurst presented a detailed discussion of the milfoil issues in Wisconsin, with information provided by Catherine Higley, a lake conservation specialist with the Vilas County Land & Water Conservation Department. She covered milfoil issues in Wisconsin, but particularly in Brandy Lake, covering what it is, how it grows and expands, what are its effects and impact, and various methods of eradicating milfoil, including financing alternatives and administrative approaches and considerations including lake associations.\* Several owners, including Ginny Comber, have been and are investigating various actions that may be taken and will provide additional information and recommendations to the board. The following article was written and submitted by Ginny Comber:

### Eurasian milfoil invasive plant crisis on Brandy Lake

As you may know, the Eurasian milfoil plant has invaded Brandy Lake. It has become a real threat. This problem was addressed at the October board meeting with a presentation from Cheri Hurst, a lake owner, who previously tried to promote a lake association.



As our board has recognized the seriousness of this milfoil invasive plant, we are asking owners to show their interest in joining a lake association by contacting Cheri (email: hurstjon@charter.net) as a first step toward finding a solution to manage this problem. If you want more information, please email Cheri to receive a link to see a presentation by Cathy Higley, an invasive plant specialist from Vilas county. Many of you have already watched her Webex presentation in September. Our commitment to the milfoil on our lake frontage will be addressed at the December board meeting. • Other New Business topics that were discussed at the October 3rd meeting are as follows: the painting of the garage doors, a concrete or asphalt apron for Garage H, a roof over the utility room door at Building G, the snow removal contract which was approved for 2020-2021 for \$8,800, the Club Cart which was generously donated by Sharon Coleman and gratefully accepted by the Association, the gutter leak behind the fascia on Building E, and the cable contract with Spectrum which expires in June 2021.

# **PROPERTY MANAGER'S REPORT**

# At the July 18th meeting:

• Lee reported on the buildings to be painted, the irrigation system repairs, the cleaning of the roofs, the new soaker hoses at the gate, the refurbished Brandy Lake sign, a new refrigerator on order for the Rec Center, the wasp control problem, the correct disposal of boxes and garbage at the garbage corrals, and a request not to feed the deer.

- Lee asked homeowners to advise him of any tree trimming they would like done to enhance the view, a key lock for the exterior garage (\$50 per owner), or painting of their garage door (owner's cost: \$65 for one-car garage and \$100 for a two-car garage).
- Lee also asked for the homeowners' input as to future capital expenditures: whether or not to grind stumps (Note: stump grinding was completed in October) and replant grass, roofing of Building A and the exterior A garage, replacing the boiler in the Rec Center, replacing the irrigation system. # At the October 3rd meeting Lee reported that:

- All projected painting was completed, 40+ trees were taken down, stumps removed, (lawn replacement to be done in 2021), all dryer vents cleaned, irrigation system is in need of repair, fire alarm system is OK, gutters on Buildings F and E to be addressed in the fall, Rec Center deck "sinking". See minutes for the October 3rd meeting for details, which is on the BLPOA website.
- Lee cited future capital expenditures at Brandy: Landscaping after tree removal, replacing pier pallets, complete roofing project, Rec Center boiler, and irrigation system.

# **GLAMOROUS GARBAGE**


